WSDOT is not authorized to use design-build on projects less than \$2m (RCW 47.20.780 and 785). All 3 projects are less than \$2m.

Since there was no delivery method other than design-bid-build that we could use for projects of this limited size, and because they are very small projects compared to all the others that CPARB is assessing, we did not bring them to CPARB for consideration.

<u>There was absolutely no intent to circumvent the proviso or CPARB process</u>, it simply did not appear to apply to these small projects. We will follow CPARB's direction related to the 9/03/24 project.

All 10 of the NSC projects are governed by the 5% pause provision in the proviso, and we have been following that for all the projects, including these 4. There is a small possibility that there could be additional emerging project(s) on the NSC similar in scope to those identified above. If that occurs, they will be routed through the CPARB process.



# **WSDOT's Design-Build Authority**

#### PDF RCW 47.20.780

#### Design-build—Competitive bidding.

The department of transportation shall develop a process for awarding competitively bid highway construction contracts for projects over two million dollars that may be constructed using a design-build procedure. As used in this section and RCW **47.20.785**, "design-build procedure" means a method of contracting under which the department of transportation contracts with another party for the party to both design and build the structures, facilities, and other items specified in the contract.

The process developed by the department must, at a minimum, include the scope of services required under the design-build procedure, contractor prequalification requirements, criteria for evaluating technical information and project costs, contractor selection criteria, and issue resolution procedures.

#### Design-build—Qualified projects.

The department of transportation is authorized and strongly encouraged to use the design-build procedure for public works projects over two million dollars when:

(1) The construction activities are highly specialized and a design-build approach is critical in developing the construction methodology; or

(2) The projects selected provide opportunity for greater innovation and efficiencies between the designer and the builder; or (3) Significant savings in project delivery time would be realized.

5	on procurement methods to the office of financial management, the
6	department, and the transportation committees of the legislature for
7	project L1000199 by July 1, 2024, and projects N52600R, N00900R, and
8	M00800R by December 1, 2024. After the board provides
9	recommendations, the department may initiate new advertisements and
10	requests for qualifications, incorporating the recommendations as
11	appropriate.
12	The department shall structure the advertisements, requests for
13	qualifications, and requests for proposals, for projects referenced
14	in this subsection, in a manner that provides a high degree of
15	certainty that bids come in as expected according to engineer
16	estimates made through the cost estimate valuation process. The
17	department may request bid offers with alternatives for components of
18	a larger project so that the department may present to the
19	legislature modified options for projects to minimize project delays
20	and stay within appropriated funding resources. If alternatives
21	provided are at or below the engineer estimates, the department may
22	proceed with the project award.
23	If bid proposals exceed engineer estimates by more than five
24	percent or \$10,000,000, the department shall report this information
25	to the transportation committees of the legislature within two weeks
26	of receiving the bid proposals, and pause award and contract
27	execution.
