








### **About Stevens County**

- 2,500 sq miles with a population of 49,300
- Population increasing by 2% each year
- Incorporated cities Chewelah, Colville,
   Kettle Falls, Marcus, Northport & Springdale
- Drug and property crimes increasing
- Race: White (85%), Native American (5%)
- Greater amount of Veterans than state avg4,100 Veterans
- Age: more residents aged 65 or older than state average



### Jail & Justice Center Project Overview

- •Average daily Jail population: 71
  - •Males: 60.38, Females: 9.96
- Jail population increased by 200 (18%) YoY
- Overcrowded-no space to address increasing mental health population
- November 2023 Voter Approved 4/10<sup>th</sup> of 1% Sales Tax Increase
- Planning 160 bed Jail Facility with Courts, Clerk's Offices & Admin
- Demolition of existing County Building & Associated Relocation
- Site Development
  - High Water Table & Poor Soils

## Why GC/CM

- Must align scope with budget
- Continuous Value Engineering and Analysis
- Continuous Constructability Reviews
- Ability to procure long lead items & start early work packages
- Continuous Cost Estimating
- Challenging site conditions
- Pre-manufacturing & complex construction sequencing of jail cells
- Coordination of activation and transfer to new facilities

### RCW 39.10

#### Complex scheduling, phasing and coordination

- Relocation of the existing Courts and Jail facilities.
- Pre-Manufactured steel cell coordination.
- Early Site / Demolition work.

#### •Involvement of GC/CM during design is critical

- Existing site conditions Soils & Water.
- Constant budget validation.
- Involvement with stakeholders.

#### Project encompasses a complex or technical work environment

- Security Electronics and Detention Equipment.
- Site Soils & Water Table.

### MWBE Outreach

- Will be the first alternative delivery project for County
- Scoring criteria through selection process plan & track record
- Work with OMWBE to get scopes of work out to as many as possible
- Ongoing subconsultant outreach
- Partner with AGC and GCCM for outreach opportunities
- APEX coordinator coordination
- As a rule, the County is focused on MWBE/DIVERSITY when feasible for each purchase & subcontractor relationship

### **Budget and Funding**

In November 2023, Stevens County voters approved two measures for a total of four tenths of one percent sales increase to fund the jail facility. The current revenue being generated is approximately \$313,933 monthly and the current tax collection has accrued \$2,057,159 thus far. Stevens County has an excellent bond rating and will be looking to sell a bond supporting the project with bonding capacity of \$99,400,000.
